NOTICE OF RACE

Includes amendments 1 - 4 posted 7/27/17

1 RULES

1.1 The regatta will be governed by:

- a. the "rules" as defined in The Racing Rules of Sailing, including Appendixes T and V;
- b. J/120 Fleet 5 rules, J/105 Fleet 1 rules;
- c. The Deeds of Gift for the following trophies: St. Francis Perpetual, the City of San Francisco Perpetual, the Atlantic Perpetual, the Keefe-Kilborn Perpetual, the Richard Rheem Perpetual, and the Commodore's Perpetual.

1.2 Yachts in the handicap divisions shall furnish their valid rating certificates no later than Tuesday, September 5th. No alteration to a yacht's rating will be permitted after this date, except: as a rating protest, to correct Rating Office errors, or with prior written permission of the Organizing Authority (OA) to be granted only in extreme circumstances with an accompanying \$500 fee.

1.3 All competitors shall wear a PFD at all times while on the water, other than brief periods while adding or removing clothing, or below deck. The 'Y' flag will not be flown. This changes RRS 40 and the preamble to Part 4.

1.4 RRS 48.2 is deleted.

1.5 US Sailing Prescriptions 63.2 and 63.4 are deleted.

2 ADVERTISING

2.1 Advertising for timepieces other than for Rolex, our title sponsor, is strongly discouraged.

2.2 Boats shall display advertising chosen and supplied by the Organizing Authority.

3 ELIGIBILITY & DIVISIONS

3.1 One Design: C&C30, Express 37, Farr 40, Pac52, J/111 and J/120 with a minimum of six (6) entries.

3.2 One Design: J/70 and J/105 with a minimum of fifteen (15) entries.

3.3 Handicap yachts with valid ORR-Fully Measured Certificate that measure a minimum of 35' LOA and have a minimum of four (4) entries.

3.4 Multihull Handicap yachts with valid BAMA certificate, a rating of -45 or faster, and minimum of 33' LOA, including pole, and have a minimum of six (6) entries.

3.5 Handicap yachts with a valid NorCal PHRF Sportboat certificate as defined by the following sportboat guidelines: Any boat with a SA_DW/D ratio ≥ 61 , a D/WL ratio ≤ 117 that carries a sprit and has a LWL $< 33'$. Yachts must also conform to the following parameters: have a minimum 28' LOA to 36' LOA, a rating between 9 and 81, and have a minimum of eight (8) entries.

3.6 Handicap division breaks will be made at the discretion of the OA.

3.7 If Class minimum entry requirements are not met by Monday, August 1st, the OA reserves the right to cancel a division. Entered boats may be assigned to the appropriate handicap division at the discretion of the OA provided they meet all eligibility requirements of that division.

3.8 For handicap divisions, the OA may reject the entry of any yacht that that may not fit the general parameters of the other yachts entered with regard to size and/or design.

4 ENTRY AND FEES

- 4.1 Eligible competitors may enter online at www.rolexbigboatseries.com before **Wednesday**, September 6th.
- 4.2 For all classes, the entry fee is \$22.00 per foot of overall boat length, rounded up to the nearest foot. Payment is available online. Payment by check must be in U.S. DOLLARS drawn on a U.S. bank and made payable to: St. Francis Yacht Club.
- 4.3 Any entry or payment for an entry received on or after August 1st will incur an additional fee of \$200.
- 4.4 An entry is not considered complete until the online entry form and fee are received.

6 SAILING INSTRUCTIONS

The sailing instructions will be available no later than 1700 on Wednesday, September 13th.

7 FORMAT, RACING AREA & COURSES

- 7.1 Race courses will be set on central San Francisco Bay and its approaches using both inflatable and fixed marks.
- 7.2 Competitors should expect to race a mix of windward/leeward and random leg courses.
- 7.3 The final race on Sunday is planned for an extended Bay Tour.

8 PENALTY SYSTEM

Decisions of the jury will be final as provided in Rule 70.5.

9 SCORING

- 9.1 Each boat's series score will be the sum of her scores for all races. This changes Appendix A2.
- 9.2 For the ORR division(s), SF Bay TOT will be used.

10 CLUB GUEST PRIVILEGES

All competitors will receive a competitor's badge at registration. A limited number of guest badges will also be given to each boat at registration. Additional guest badges may be purchased at the Front Desk. Anyone wishing to purchase food and/or beverages must obtain a Yacht Club Guest Card at the Front Desk upon arrival.

11 BERTHING & TRAILER STORAGE

- 11.1 All yachts competing in the event may be moored free of charge at pre-assigned locations beginning on Monday, September 11th until Monday, September 18th. We will make every attempt to dock all competitors close to St. Francis Yacht Club but please be aware due to limited dock space, it may not be possible.
- 11.2 Storage of any sailing equipment or boat gear is not permitted on any docks. Violation of this rule may result in the removal of docking privileges during the event, a fine as administered by the San Francisco Marina Yacht Harbor office and/or a \$250 administered by the St. Francis Yacht Club.
- 11.3 Please note that the parking area surrounding the St. Francis Yacht Club is City property. Competitors who would like to keep a trailer (storage or boat) in the City parking lot must visit the Race Office immediately upon arrival for an overnight parking permit. Trailers without permits may be towed.
- 11.4 All boats and trailers will be stored at the direction of the StFYC Dock Master or Race Coordinator.

12 PRIZES

Trophies will be awarded based on fleet participation.

13 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The Organizing Authority and its sponsors will not accept any liability for material damage, or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.
